- Bids should be valid for a minimum period of ninety days after the due date. Quotations should be addressed by designation and the sealed envelope containing the quotations is to be addressed by name to officer signing this enquiry.
- The bidder must be a reputed manufacturer, National distributors. Or his authorized partners. copy of specific tender authorization may be enclosed. If incomplete in these respects the quotation is liable to be rejected.
- ISO certificate (latest) or its authorized representative of the type of products. In case of representative, the authorization letter from the OEM may be submitted along with copy of ISO Certificate.
- The bidder should have at least Five years experience in AMC of KTS systems of similar configuration to Govt. Department/PSUs/reputed Organization.
- 5. The bids must reach the undersigned on or before the due date i.e. 19.8.2020 by 3 PM Bids received after due date and time are liable to be rejected. Technical bids shall be opened on the same day at 3.30 pm in Room No. 685, Publication Division, Soochna Bhawan, Phase V, New Delhi in the presence of Bidders, who may like to be present.
- It may be specifically mentioned whether quotation in strictly as per tender specification / conditions. If not, deviation must be spelt out specifically in the technical bid. In the absence of these, the quotation will be rejected.
- Registration number of the firm along with the CST No./ VAT No. / ESI No/ EPF No. Service Tax No. allotted by the concerned authority should be duly mentioned and copies attached should be submitted along with your quotation. If incomplete in these respects the quotation is liable to be rejected.
- 8. Bidder shall sign all pages of quotation and drawing forwarded with the quotation.
- 9. In case of any discrepancies between rate mentioned in the figures and word, the later shall prevail. Further in case of any discrepancy between unit price and total price, the price quoted; as unit price shall prevail.
- 10. The Directorate may waive infirmities or seek clarification, If so desired.
- 11. Any attempt of negotiation direct or indirect on the part of the tenderer with the authority to whom he has submitted the tender or authority who is competent finally to accept it, after he has submitted the tender or any endeavor to secure any interest for an actually or prospective tenderer or to influence by any means the acceptance of the particular tenders will tender the tenderer liable to be excluded from consideration.

- 12. Each quotation must be accompanied with Earnest Money Deposit for Rs.15,000/-(Rupees Fifteen Thousand only) shall be in the form of Demand Draft/Pay Order in the name of <u>DDO (Cash), DPD, New Delhi</u>. Quotations received without Earnest Money Deposit are liable to be rejected. The rates must be excluding of VAT / CST, which shall be paid by the Directorate separately as applicable. However, these would be considered at the time of evaluation.
- 16. All disputes are subject to the jurisdiction of court in the National Capital Territory of Delhi and Agreement will be governed by and be construed in accordance with laws of India.
- 17. The Directorate reserves the right to accept or reject any bid or cancel the tender proceeding without assigning any reason whatsoever.
- 18. The Arbitration proceedings will b held in New Delhi. The Arbitrator will give reasons for his award and the award passed by the Arbitrator shall be final and binding upon the parties herein. Such reference shall be deemed to be a submission to arbitration under the Indian Arbitration and conciliation Act, 1996 or of any modifications or reenactment there of including the rules framed there under.
