#### 3. Background:

#### 3.1 **Introduction:**

Publications Division (PD) is a repository of books and journals highlighting subjects of national importance and India's rich cultural heritage. The mandate of the organization is to preserve national heritage and disseminate the same through the production and sale of quality reading material at affordable prices. Publications Division publishes non-fiction books and journals on diverse aspects of Indian panorama, ranging from art and culture, land and people, flora and fauna, biographies of the Builders of Modern India, Gandhian Literature, Cultural Leaders of India, India's History, Freedom movement, children's literature among many other subjects. It publishes books in Hindi, English and other regional languages. It also publishes books containing compilation of Speeches of President ,Vice-President and Prime Minister.

- 3.2 Books on Gandhian literature hold the place of pride for Publications Division with several books on Gandhian thought including the Collected Works of Mahatma Gandhi(CWMG) in 100 volumes, published in English and Sampoorna Gandhi Vangmaya in Hindi. Publications Division in association with Rashtrapati Bhavan, Supreme Court of India and Election Commission of India has published a series of high quality books on various aspects of Indian President's official residence and its functioning, Courts of India and Election History etc.
- 3.3 Presently, PD has around 2400 live titles and these are knowledge imparting publications which need to reach the nook and corner of the country.
- 3.4 Publications Division is also publishing magazines and journals on various aspects of Indian life. Yojana, with its 13 language editions, is the flagship magazine on development-related issues. Kurukshetra, in English and Hindi, is devoted to rural development. Aajkal, in Hindi and Urdu, is a prestigious literary magazine. Bal Bharati is a popular children's magazine in Hindi. Employment News, in English, Hindi and Urdu, is a weekly dedicated to providing valuable and authentic information on jobs in central government, including the public sector.
- 3.5 Digitization is a new intiative of Publications Division. Under the scheme of "Media Infrastructure Development Programme" over 2000 titles were digitized and at present the Digital Archives has a repository of over 1600 titles. #### 4. Aims & Objectives:

(ix) Sell the e-books only within India. For selling in the International market, the prior permission from PD needs to be taken. In that case the Digital Listed Price(DLP) of e-books will be changed but there will be no change in the Revenue sharing model i.e 70:30(PD: E-Resource Aggregator).

#### 5. IOA Processing Fees

## <u>DETAILED TERMS & CONDITIONS FOR EMPANELMENT OF E-RESOURCE</u> <u>AGGREGATOR(ERA)</u>

#### 1. OBJECTIVE:

Publications Division (PD) is an attached office under the Ministry of Information & Broadcasting, Government of India and having its office at Soochna Bhawan ,Lodhi Road, New Delhi-110003. The objective is to define a working relationship between the PD and ERA for online hosting services, licensing and sale of Publications.

#### 2. GRANT OF RIGHTS:

- 1. PD will grant a non-exclusive license for E-publishing, hosting, aggregation and distribution of the Publications listed in the PD Price List. Roles and responsibilities of e-Resource Aggregator and DPD will be set as per an agreement.
- 2. PD owns the copyright for the Publications, with E-publishing rights assigned to e-Resource Aggregator under the agreement. PD 's copyright notification shall be distinctly displayed in every Publications item displayed online to the users. In addition, PD hereby licenses e-Resource Aggregator to use its name, logo and associated trademarks of the Publications, limited for the purpose of marketing and distributing the Publications, during the Term.

#### 3. SERVICES TO BE PROVIDED BY E-RESOURCE AGGREGATOR:

Following are the services that will be provided by e-Resource Aggregator to PD

- 1. E-Resource Aggregator will host and distribute the Publications online.
- 2. E-Resource Aggregator will provide access to Publications to both individual as well as institutional users.
- 3. E-Resource Aggregator will provide usage and revenue reports to PD.

#### 4. RESPONSIBILITIES OF E-RESOURCE AGGREGATOR:

- 1. E-Resource Aggregator shall manage access rights to Publications to the authorized users, based on any rules, requirements, security or privileges mutually agreeable by the PD and E-Resource Aggregator.
- 2. E-Resource Aggregator will undertake the responsibility for marketing and sales of e-pub/e-version of the Publications through its platform under a revenue share model.
- 3. E-Resource Aggregator will, to the extent possible, keep the Database updated with the latest information available from PD.
- 4. E-Resource Aggregator will share with PD information relating to Revenue from sale of Publications on a regular basis by providing monthly reports and through publisher relation desk.
- 5. E-Resource Aggregator's business model for Publications' delivery to individuals/institutional user shall be by way of download of Publications through e-Resource Aggregator.
- 6. E-Resource Aggregator will support and provide assistance to the Users/ Subscribers of the publication consuming from E-Resource Aggregator portal.
- 7. E-Resource Aggregator can sell the e- books only within India. For selling in the institutional market, the prior permission from PD needs to be taken. In that case the Digital Listed Price/Price of e-books will be changed but there will be no change in the Revenue sharing model i.e 7:3.

#### 5. ACCESS THROUGH THE ERA PLATFORM:

ERA will aggregate and market Publisher's content through its platform. ERA shall own all information regarding the customers.

#### 6. FEES, PRICING AND REVENUE SHARING:

- 1. PD shall establish a suggested retail price (exclusive of GST applicable) for each e-book (the "Digital List Price").
- 2. PD shall be free to change the Digital List Price(s) of any E-book at any time and will confirm the updated Digital List Price(s) for any E-book via its metadata. In no event shall the actual retail price be more than the Digital List Price(s) for any E-Book.
- 3. E-Resource Aggregator shall pay to PD 70% of digital list price on all copies sold.
- 4. E-Resource Aggregator shall as principal, sell the E-Book copies to the customers and shall assume all risk of non-payment by the customers, and shall pay the amount for every copy of the E-book sold by the E-Resource Aggregator without any deduction or withholdings. E-Resource Aggregator shall be deemed to have sold 5 (five) E-Books each time that a copy thereof is made available to a customer by E-Resource Aggregator for one electronic delivery of publishing to the customer.
- 5. All sums payable by E-Resource Aggregator to PD shall be paid through WIRE Transfer/Online Transfer.
- 6. E-Resource Aggregator has to give a Bank Guarantee of Rs.2,00,000( Two Lakhs only) to PD before signing the agreement.

#### 7. ACCOUNTING:

- 7.1 Within thirty (30) days of the end of each calendar month during the Term, starting with the first month that the e-books are available for sale on the platforms, ERA will send to PD a monthly statement in respect of that previous calendar month in a digital format accompanied by payment in full of the amount due and owing to PD for the relevant month.
- 7.2 PD shall have the right to audit and examine the ERA books, records, platforms by furnishing at least seven (07) days prior written notice to ERA.
- 7.3 In addition to the other rights and remedies available to PD in respect of unpaid money due to it, any late payment will attract interest at the rate of 12% p.a. from the date payment is due until the date of actual payment. Nothing in this sub-clause shall be applicable unless ERA withholds the aforementioned payment due to PD without any reasonable cause for a period of more than forty (40) days to be calculated from the date the payment becomes due and payable to PD.

#### 8. TERMS AND TERMINATION:

- 8.1 The term of the agreement shall be for one year from the effective date of agreement and will be automatically renewed for successive term of 1 year, unless cancelled by either party by giving a written notice of 30 days.
- 8.2 In case of insolvency, bankruptcy or liquidation of any Party, the other Party may terminate this agreement by giving at least 30(thirty) days prior written notice to the other Party.
- 8.3 PD has right to withdraw specific titles as per discretion, but customers who have already bought the titles prior to the withdrawal date will continue to have access rights.

#### 9. EMPLOYEES SOLICITATION:

Both parties i.e PD and ERA agree not to induce/solicit, directly or indirectly, the employees of either party during the period of agreement and for one (1) year following the termination of this agreement.

#### 10. INDEMNIFICATION:

- 10.1 Each party except otherwise provided in the Agreement shall indemnify, keep indemnifies and hold harmless the other Party against any claim, action demand, expense, loss or other liabilities whatsoever which may arise as a result of or consequence of its negligence and/or omission and /or failure to fulfill its obligations under this Agreement and /or under any terms of any applicable law or regulation.
- 10.2 Publisher indemnifies ERA against any loss, claim, action, liability of whatsoever that may arise as a consequence of Publisher's existing relation/agreement/MOU with previous associates, printer, author, other patron etc, in relation to this agreement.
- 10.3 Publisher also indemnifies ERA against and loss, claim, action, liability of whatsoever nature arising due to infringement, plagiarism, violation of clause 6,delay reported by other authors, librarian ,institutes or any other competent authority due to negligence and/or omission and/or failure by Publisher and/or existing/previous employee, associate, printer, author or other patron etc.

#### 11. SECURTIY AND DRM:

- 1. E-Resource Aggregator shall use and shall ensure to protect the security of all E-books and any other materials provided by PD pursuant all user information in their possession or control.
- 2. E-Resource Aggregator shall maintain effective Digital Rights Management (DRM) protection for the platforms and each E-Book made available via the platforms in compliance with the DRM Specifications as per our DRM policy.
- 3. E-Resource Aggregator must immediately notify PD of any breach or suspected breach of security (including any unauthorized use, disclosure, or acquisition of or access to the E-Books or any other material provided by PD or to the user information) or digital rights management protection with respect to the E-Books and take corrective measures.

#### 12. TRADE MARKS AND INTELLECTUAL PROPERTY:

- 12.1 PD hereby grants to ERA for the term a non-exclusive license to post the names and logos in respect of the relevant e-books made available on the platforms solely for the purpose of indentifying the relevant publisher thereof. All goodwill from use shall ensure to the benefit of PD.
- 12.2 All rights in the e-books and any Intellectual Property Rights of PD not specifically granted in this Agreement by PD are reserved by and to PD.
- 12.3 ERA will not use or authorize the use of the E-books and will not distribute or make the e-books available other than as expressly authorized in this Agreement.

#### 13. RELATIONSHIP OF THE PARTIES

The relationship between Publisher and Era is not and shall not be considered a partnership, franchise, or joint venture. Both parties are and shall remain independent organizations. Neither party shall have no authority and shall take no action ,or shall refrain from taking an action indicating that it has authority , to bind the other Party to any obligation.

#### 14. CONVENANTS:

PD and ERA hereby jointly covenant that they shall employ their reasonable endeavours and cooperate with each other to discharge their respective obligations under this Agreement.

#### 15. FORCE MAJEURE:

- 15.1 If any event of force majeure continues for a period in excess of forty five(45) consecutive days, resulting in the inability of a Party to perform its business activities under the terms of this Agreement, either Party shall be entitled to terminate this Agreement upon written notice to the other party. In this case there will be no liability on either Party.
- 15.2 The term force majeure used above shall mean acts of good, acts of any public enemy, wars , hartals, blockades, insurrection, riots, epidemics, landslides, lightening, earthquake, fires, storms, floods, civil disturbances, terrorisms and any other cause not within the control of the affected Party, all of which by the exercise of due diligence such Party is unable to prevent.

- 3. E-Resource Aggregator will provide usage and revenue reports to PD.

#### C. RESPONSIBILITIES OF E-RESOURCE AGGREGATOR:

- 1. E-Resource Aggregator shall manage access rights to Publications to the authorized users, based on any rules, requirements ,security or privileges mutually agreeable by the PD and E-Resource Aggregator.
- 2. E-Resource Aggregator will undertake the responsibility for marketing and sales of e-pub/e-version of the Publications through its platform under a revenue share model.
- 3. E-Resource Aggregator will, to the extent possible, keep the Database updated with the latest information available from PD.
- 4. E-Resource Aggregator will share with PD information relating to Revenue from sale of Publications on a regular basis by providing monthly reports and through publisher relation desk.
- 5. E-Resource Aggregator's business model for Publications' delivery to individuals/institutional user shall be by way of download of Publications through e-Resource Aggregator.
- 6. E-Resource Aggregator will support and provide assistance to the Users/ Subscribers of the publication consuming from E-Resource Aggregator portal.
- 7. E-Resource Aggregator can sell the e-books only within India. For selling in the institutional market, the prior permission from PD needs to be taken. In that case the Digital Listed Price/Price of e-books will be changed but there will be no change in the Revenue sharing model i.e 7:3.

#### D. FEES, PRICING AND REVENUE SHARING

- 1. PD shall establish a suggested retail price(exclusive of GST applicable) for each e-book(the "Digital List Price").
- 2. PD shall be free to change the Digital List Price(s) of any E-book at any time and will confirm the updated Digital List Price(s) for any E-book via its metadata. In no event shall the actual retail price be more than the Digital List Price(s) for any E-Book.
- 3. E-Resource Aggregator shall pay to PD 70% of digital list price on all copies sold.[]]
- 4. E-Resource Aggregator shall as principal, sell the E-Book copies to the customers and shall assume all risk of non-payment by the customers,

and shall pay the maount for every copy of the E-book sold by the E-Resource Aggregator without any deduction or withholdings. E-Resource Aggregator shall be deemed to have sold 5 (five) E-Books each time that a copy thereof is made available to a customer by E-Resource Aggregator for one electronic delivery of publishing to the customer.

- 5. All sums payable by E-Resource Aggregator to PD shall be paid through WIRE Transfer/Online Transfer.
- 6. E-Resource Aggregator has to give a Bank Guarantee of Rs.2,00,000( Two Lakhs only) to PD before signing the agreement.

#### E. TERM AND TERMINATION

- 1. The term of the agreement shall be for one year from the effective date of agreement and will be automatically renewed for successive term of 1 year, unless cancelled by either party by giving a written notice of 30 days.
- 2. In case of insolvency, bankruptcy or liquidation of any Party, the other Party may terminate this agreement by giving at least 30(thirty) days prior written notice to the other Party.
- 3. PD has right to withdraw specific titles as per discretion, but customers who have already bought the titles prior to the withdrawal date will continue to have access rights.

#### F. SECURTIY AND DRM

- i. E-Resource Aggregator shall use and shall ensure to protect the security of all E-books and any other materials provided by PD pursuant all user information in their possession or control.
- ii. E-Resource Aggregator shall maintain effective digital rights management(DRM) protection for the platforms and each E-Book made available via the platforms in compliance with the DRM Specifications as per our DRM policy.
- iii. E-Resource Aggregator, must immediately notify PD of any breach or suspected breach of security (including any unauthorized use, disclosure, or acquisition of or access to the E-Books or any other material provided by PD or to the user information) or digital rights management protection with respect to the E-Books and take corrective measures.

#### 2. Accounting

- 2.1 Within thirty(30) days of the end of each calendar month during the Term, startin with the first month that the e-books are available for sale on the platforms pursuant to this Agreement, ERA will send to PD a monthly statement in respect of that previous calendar month in a digital format accompanied by payment in full of the amount due and owing to PD for the relevant month.
- 2.2 PD shall have the right to audit and examine the Era books, records, platforms by furnishing at least seven (07) days prior written notice to ERA.
- 2.3 In addition to the other rights and remedies available to Pd in respect of unpaid moneys due to it under this Agreement, any late payment will attract interest at the rate of 12% p.a. from the date payment is due until the date of actual payment.

Nothing in this sub-clause shall be applicable unless ERA withholds the aforementioned payment due to PD without any reasonable cause for a period of more than forty(40) days to be calculated from the date the payment becomes due and payable to PD.

#### 3. Trademarks & Intellectual property

- 3.1 PD hereby grants to ERA for the term a non-exclusive license to post the names and logos in respect of the relevant e-books made available on the platforms solely for the purpose of indentifying the relevant publisher thereof. All goodwill from use shall ensure to the benefit of PD.
- 3.2 All rights in the e-books and any Intellectual Property Rights of PD not specifically granted in this Agreement by PD are reserved by and to PD.
- 3.3 ERA will not use or authorize the use of the E-books and will not distribute or make the e-books available other than as expressly authorized in this Agreement.

#### 4. Relationship of the Parties

The relationship between PD and Era is not and shall not be considered a partnership, franchise, or joint venture. Both parties are and shall remain independent organizations. Neither party shall have no authority, and shall take no action, or shall refrain from taking any action indicating that it has the authority, to blind the other party to any obligation.

#### 5. Eligibility Criteria:

All the firms seeking empanelment as ERA should meet the following qualifying criteria and submit their applications along with relevant documents as detailed below:

- a. A bonafide ERA having at least one year of experience in distributing books/e-books
- b. The registered book publisher with at least 1(0ne) year of experience and minimum turnover of Rs10 lakhs (cumulative) in 2018-19. However, for the states of North East and Jammu & Kashmir, the minimum turnover requirement will be Rs.1 lakh.
- c. Certificate showing the date of initial registration of shop indicating business in book trade issued by Central Government/State Government/Local Bodies (Tehsildar, Municipal Corporation. SDM, DM) establishing 5 years existence of the firm.
- d. Income Tax or Sales Tax returns in 2018-19 establishing at least one year existence of the firm indicating business in book trade/distribution
- e. Copies of annual accounts, namely, Trading Account, Profit and Loss Account and the balance sheet for the financial year 2018-19 duly authenticated by chartered accountant indicating annual turn over, this being not less than the annual target of sale of DPD publications.

f. Self certified copy of PAN card in the name of proprietor in case of a proprietary firm or in the name of the firm in case of a partnership/Pvt. Ltd Company.

#### 6. Period of Contract:

The contract will be valid for two years, i.e., from 1st ......, 2019 to 31st ......., 2021. The contract can be extended further on mutually acceptable terms and conditions depending on the satisfactory performance of the wholesale dealers / distributors. If any party wishes to discontinue the contract, a notice period of three months is required. However, if at any stage it is found that the Distributor has flouted any terms and conditions or indulged in any practice that is not in conformity with the law, DPD shall have the right to terminate the contract/distribution ship without any notice.

#### 7. Process of Selection:

Empanelment of e-resource aggregator will be based on technical scrutiny in response of such eligible distributors who shall apply in respect to an open advertisement to be issued by Publications Division at an appropriate stage. A duly constituted committee of Publications Division shall evaluate such responses on the basis of following indicative parameters:

- (i) Number of years of experience in distributing e-books/journals;
- (ii) Turnover for the last year;
- (iii) Number of offices in the concerned State where the applicant wishes to apply for empanelment;
- (iv) Number of towns/cities in the State being serviced by the applicants for e-books/journals for the last year;
- (v) Number of publishers associated with the applicant;
- (vi) Number of e-books/journals distributed by the applicant during the last year;
- (vii) Number of cities/towns serviced by the applicant in other States; and
- (viii) Number of offices of the applicant in other States.

The above parameters are only indicative in nature and the final bidding document will be put up in public domain by the Publications Division.

The empanelled e-resource aggregator shall have the option of applying for one or more State but the processing of applications will be on a State-wise basis. Department may give preference to the one having presence in adjoining States for the purpose of giving an advantage in terms of coordinated sales and marketing strategy spread across the region and not just limited to a State.

7.1 **Process for Existing Agents:** Existing ERA can apply afresh against this IOA for empanelment. In case, the existing agents don't apply for this empanelment, Publications Division reserves the right to assign the existing agents as e-resource aggregator that may be empanelled on the basis of this IOA.

#### 7.2 **Price of Digital Publications and Marketings tie-**ups with e-tailers

**For e-**books, e-journals & e-aggregators:

- (a) e-books will be available to customers through different platforms including e-commerce platforms along with the website of Publications Division.
- **(b)** The price of e-books/e-journals to be at par with print books with 25% discount on the price to be passed on to buyers. In effect it would be 75% of the p-book.
- (c) Publications Division to utilize the marketing platform for sale of its e-books/e-journals with a revenue sharing ratio of 70:30(DPD: ERA) on the realised amount through sales of e-books/e-journals being compliant with Indian laws.
- (d) Additional Special discount of up to 20% offers for a period of not exceeding 10 days could be provided on National Holidays or Important days such as World Book Day, Republic Day, Independence Day, Gandhi Jayanti etc.

#### 8. Terms of payment:

All supplies of DPD publications will be made on pre-payment basis, i.e. payment through Demand Draft or electronic transfer. The credit facility shall also be allowed subject to submission of EMD to the tune of 100% of sales calculated for a stock value of one month of supply.

#### 9. Supply of books:

Once a firm order is received from wholesale dealers / distributors and payment made or EMD submitted, DPD will supply the publications at his registered address / address of shop or godown as desired by him within the period of 21 days from receipt of payment subject to availability of stock for which the concerned agent wound need to enquire before placing of order.

#### 10. Performance Bank Guarantee/Fixed Deposit Receipt (FDR):

E-Resource Aggregator has to give a Bank Guarantee of Rs.2,00,000(Two lakhs only) to Publications Division before signing the agreement.

#### 11. List of Documents to be attached:

- 11.1 Copies of annual accounts, namely, Trading Account, Profit and Loss Account and the balance sheet of the last the year duly authenticated by chartered accountant indicating annual turnover.
- 11.2 Self certified copy of Income Tax return for the last year i.e.2018-19 and PAN card in the name of proprietor in case of a proprietary firm or in the name of the firm in case of a partnership/Pvt. Ltd Company.

- 11.3 Copy of GST Registration/GST number
- 11.4 Submission of supporting documents to establish offices in various cities/towns of India
- 11.5 Supporting documents to establish books being distributed by the applicant (publications with RNI No.)
- 11.6 Supporting documents to establish the number of publishers with whom the applicant is associated for marketing/distribution
- 11.7 Supporting document to establish number of towns/cities from where the applicant is distributing.

#### 12. <u>Indicative Evaluation criteria:</u>

- 12.1 Number of years of experience in distributing books;
- 12.2 Turnover for the last three years;
- 12.3 Number of offices in a particular state;
- 12.4 Number of towns/cities being serviced by the applicants for Distributing books for the last three years
- 12.5 Number of publishers associated with the applicant;
- 12.6 Number of books currently distributed by the applicant;

#### 13. Penalty Clause:

In case of dishonour of payment, a penalty of 5% against the outstanding payment will be imposed.

#### 14. Termination of Contract:

- 1. The term of the agreement shall be for one year from the effective date of agreement and will be automatically renewed for successive term of 1 year, unless cancelled by either party by giving a written notice of 30 days.
- 2. In case of insolvency, bankruptcy or liquidation of any Party, the other Party may terminate this agreement by giving at least 30(thirty) days prior written notice to the other Party.
- 3. PD has right to withdraw specific titles as per discretion, but customers who have already bought the titles prior to the withdrawal date will continue to have access rights.

#### **16. Notice:**

Any notice or other communication given pursuant to this Agreement shall be in writing and shall be effective either when delivered personally to the party for whom intended, or five (5) days following deposit of the same into the mail( registered or recorded post or first class postage prepaid) or other local equivalent postal service, if sent by facsimile on receipt of confirmation of delivery if sent on a business day in the place of receipt, on opening of the business on the next business day or the next day if sent by overnight delivery services ( with confirmation of delivery), addressed to such party at the address set forth on the initial page of this Agreement. Either party may designate a different address by notice to the other given in accordance with the terms of this clause.

#### 17. Force Majeure

- 17.1 Neither party shall be liable for any delays or failures in performance in whole (or in part) of its obligations under this agreement, if such delay or non-performance is due to any act of god, war, terrorism, insurrection, riot, civil disturbance, rebellion, government regulation, embargo, explosion, fire, flood, tempest, strike, or failure in lighting, electrical power or telecommunications equipment, circuits, or other events beyond the reasonable control of the party whether or not similar to the foregoing (an" event of Force Majeure"). In any such event the parties will discuss the feasibility of continuing the provision of the services, including the cost related thereto.
- 17.2 In the event that the event of Force Majeure persists for a period of 30 business days or more and whichever party's performance is affected by the event of force majeure, either party shall be entitled to terminate the relevant Order under this Agreement unilaterally without liability to the other in respect of such termination. Upon such termination, Client shall pay Publications Division for all services rendered and expenses incurred by Personnel up to and including the date of termination and demobilization costs resulting from such early termination as provided for in the relevant Order. In the event of such termination, Client acknowledges that the services will be work in progress and may not be in a finished state.

#### 18. Arbitration Clause:

The provisions of the Arbitration and Conciliation Act, 1996 will be applicable and the award made there under shall be final and binding upon the parties hereto, subject to legal remedies available under the law. Such differences shall be deemed to be a submission to arbitration under the Indian Arbitration and Conciliation Act, 1996, or of any modifications, rules or re-enactments thereof.
